



New eStatement Enrollment Procedures

Once signed into Online Branch, click on **eStatements**.



Members will then select an account number from the dropdown menu to sign up and click **Continue**. If there are multiple online accounts, each account will need to be enrolled individually.



A new window will open (pop-up blockers must be disabled). Members will then be taken to our **Electronic Statement Disclosure Agreement**. After reading the disclosure, members need to click on the **Agree** link in order to proceed.

Big Island Federal Credit Union Electronic Statement (eStatement) Disclosure Agreement

Please read this information carefully and print a copy and/or retain this information electronically for your records

This Agreement is between Big Island Federal Credit Union (hereinafter "we, us, our or Credit Union"), and each participating member of the Credit Union's eStatement program, together with any person who is authorized by a member to use or access this service (hereinafter referred together as "you, your or yours").

Electronic Delivery of Statements. By accepting the "Electronic Statement (eStatement) Disclosure Agreement", you agree to permit Big Island Federal Credit Union to make disclosures and provide notices to you in electronic form, including electronic delivery of statement notifications (eStatements), instead of providing such notices and disclosures in written form for all accounts you are enrolled in now and in the future.

We are required to obtain your consent before delivering electronic communications. Your consent and agreement shall relate to all forms of disclosures and notices required under applicable law as a result of the various agreements between you and the credit union and shall remain valid until such time as you exercise your right to revoke this consent. You elect and authorize us, at our discretion, to electronically deliver your account statement(s) and notices that we are required to provide you under applicable Federal and State statutes and their implementing regulations, as amended from time to time.

Terms and Conditions of Your Electronic Statement Agreement. By entering into this Agreement, you accept all the terms and conditions contained in the Agreement. Please read it carefully.

The terms and conditions of your Member Service Agreement for each of your credit union accounts as well as your other agreements with the credit union such as loans continue to apply notwithstanding anything to the contrary in this Agreement. You agree to be bound by any and all laws, rules, regulations and official issuances applicable to eStatements now existing or which may hereafter be enacted, issued or enforced, as well as such other terms and conditions governing the use of other facilities, benefits or services that credit union may from time to time make available to you in connection with eStatements. This Agreement is binding upon your heirs and the credit union's successors and assigns. Certain of the obligations of the parties pursuant to this Agreement that by their nature would continue beyond the termination, cancellation or expiration of this Agreement shall survive termination, cancellation or expiration of this Agreement.

Consent to Electronic Delivery of Account Statements. You have the right to receive monthly, printed Account statements mailed to your mailing address of record. By entering into this Agreement, you understand that the credit union will cease providing you with printed statements in the mail, and that all future account statements will be eStatements which will be
